**Job Summary:**

- Two-week instructional position available in BPS Summer Scholars Program for middle and high school teachers.
- Designed for BPS students entering grades 6-11 identified as struggling in reading or writing.
- Free to invited BPS students and supported by Birmingham Education Foundation grant.
- Location: BPS Location TBD and/or Remote Instruction (Location will depend on state/CDC guidelines and registration needs.)
- Dates: August 10 – August 21, 2020

**Major Duties and Responsibilities:**

- The camp will run for a total of 10 days during either the hours of 9:00 a.m. and 11:00 a.m. or the hours of 1:00 p.m. and 3:00 p.m.
- Teachers will instruct students for two hours each day, including whole-group, small group, and individualized instruction.
- Teachers will spend an additional hour each day planning lessons and/or conferring with individual students/small groups as needed.
- Teachers will collaboratively develop age-appropriate, interactive lessons that are of high interest to students and designed to provide direct instruction and support around fundamental reading/writing skills.
- Teachers are expected to attend one half day of collaboration before camp begins to learn ed. tech. tools and best practices for remote teaching.
- Teachers will teach grade-specific classes between Grade 6 and Grade 11.
- Teachers will work with up to 20 at-risk students drawn from across the district.
- Classes will be conducted daily in accordance with camp hours.

**Qualifications:**

- Member of the BPS teaching staff, preferred
- Holds valid and current Michigan teacher certification in secondary English

**Compensation:**

- Compensation includes \$1,000 upon completion of the summer session (2 weeks). Teachers will provide direct instruction around foundational literacy skills for two hours per day.
